Pinceon (Pinco, Pincheun, etc) supposedly was a Norman soldier who accompanied William the Conqueror to England in 1066. This would place his birth as earlier than 1050. If this is correct, he must have been a very young participant in the conquest.

Dugdale wrote, "At the time of the Norman Conquest, Eudo, who, together with one Pinco his sworn brother in war (although otherwise not allied), came to England with Duke William, merited so well from him in that service, as that for recompense thereof they obtained of his gift the lordship of Tateshall, with the hamlet of Thorp and town of Kirkby, in county Lincoln, to be equally shared between them; Eudo to hold his proportion immediately of the King, and Pinco his of St. Cuthert of Durham." (Beke, 333)

Of the credible sources which mention Pinceon, only Dugdale states that he came with the Conqueror. Other sources only attribute the family back to Pinceon, but do not insist that he came with the Conqueror. (Battle Abbey, 120; Burke, 38; Beke, 331-335; Banks, 122 (errors))

Twenty years after the Conquest, in 1086, Eudo son of Spirewic was listed with 34 properties in the Domesday Book of Lincolnshire. (Foster, 135-138) But there is no mention of Pinceon. It seems more reasonable to this compiler that

Pinceon was still underage in 1086 and did not yet hold any property. It may seem ridiculous for this compiler to contradict Dugdale, but he does have errors in other parts of his work. (for example, the Bek family)

If Pinceon was underage in 1086, then he was born after 1065, but based on his son's age, Pinceon was possibly born before 1075. So, this compiler will estimate Pinceon's birth as 1066-1075.

At the time of the Lindsey Survey (1115-1118), "Pinceon the sewer" held a number of properties, all of Ranulf, Bishop of Durham:

2 carucates and 7 bovates in Haverstoe Wapentake (Foster, 248) 4 carucates and 3 bovates in Candleshoe Wapentake (Foster, 253) 2 bovates in Ulceby in Calcewath Wapentake (Foster, 254) 3 carucates and 2 bovates in Bullington in Wraggoe Wapentake (Foster, 255)

4 carucates and 6 bovates in Fulletby and Oxcombe in Hill Wapentake (Foster, 257)

A sewer was a medieval household officer of high rank in charge of serving the dishes at table and sometimes of seating and tasting. We would use the word "steward" now.

Pinceon was living in at the time of the Lindsey Survey of 1115-1118. If he had been a participant in the Conquest in 1066 (born prior to 1050), he would have been at least 65 years of age in 1115. However, if he had been born closer to 1070, then he would have been about age 45 in 1115, a more reasonable age in that era.

Pinceon's wife and children other than Hugh are unknown. There may have been other children who would not have been recorded because only the oldest surviving son inherited any property. Since Pinceon was in the upper class in Lincolnshire, it should be stated that after the Conquest, the upper classes which were primarily Norman spoke French and records from this period were recorded in Latin.
